2025/2026 Snow Removal Residential Contract

Higher Ground will perform routine snow removal to the property in snow events of 3+/- inches, with one plow per 24 hour period. The contract will start November 1, 2025 and extends through April 30, 2026. Exceeding 10 plows per month may result in additional charges. Additional snow removal and pushbacks may be necessary in order to maintain snow storage areas and will be performed on a discretionary basis or when requested by the customer for an additional fee. In extreme cases, removal of snow to offsite locations may also be necessary and will be performed for an additional fee.

Some accounts may have limited snow storage and additional snow removal may be necessary in order to maintain all accesses. The following are a list of machine rates for these services.

Push backs-Machine Rate - Minimum One (1) Hour Billed

Push backs may be required using different machinery. Hourly Rates Indicated Below:

Skid Steer Loader- \$180.00 per hour

Wheel Loader - \$190.00 per hour

Industrial Snowblower - \$200.00 per hour

Mini Excavator - \$180.00 per hour

Hauling Fee - \$165.00 per hour

Diposal Fee - Rate Varies on location

Manual Labor - \$90.00 per hour

Single Plow Visit - varies per location

Terms and Conditions:

Higher Ground Earthwork’s primary objective is to increase and enhance accessibility and safety by providing routine snow removal. In order to provide the most effective and efficient service, we use our discretion of when to mobilize for plowing operations. Plowing WILL NOT provide a snow/ice free environment. High alpine conditions are to be expected. Dangerous and slippery conditions may always be present. Higher Ground Earthworks will not apply sand, salt or traction products. Snow removal operations may not always improve the conditions or make for a safer environment. Higher Ground Earthworks will not be responsible for stuck vehicles, loss of revenue, car inaccessibility, of, but not limited to EMS, fire, police or other service vehicles. Higher Ground Earthworks will not be held responsible for injury or death related to snow removal operations including, but not limited, to any and all slip, trip or fall cases. Higher Ground Earthworks will not be held responsible for damage to driveways, utilities (ie. well heads, sewer cleanouts, curbstops), irrigation, landscaping, fences, windows, walls, steps, trees, shrubs and grass as well as any other landscaping features. Higher Ground Earthworks will not be held responsible for damages due to avalanches, drifted or stacked snow, falling snow, ice, ice dams or water. All agreements are contingent upon accidents or delays that extend beyond our control.

I agree to pay the monthly invoices being sent on the first of each month, starting November 1, 2025 and with service ending on April 30, 2026.
